

Citation Guide - Chicago

It is possible to cite within the Chicago-style in two different ways:

- a) Notes and bibliography
- b) Author-Date

To determine which citation style you should use, simply ask your instructor. Generally though, the author-date style is used by practitioners within the sciences and social sciences, while notes and bibliography is preferred by those who are working in the humanities (similar to MLA).

The difference between these two citation styles is miniscule as they are only limited to the usage of footnotes and shortened notes (notes and bibliography) over parenthetical references (authordate). Otherwise, the information required within the bibliographic entries and overall formatting is similar.

If you ever feel daunted by citations, then please do keep in mind that citations are simply formulas. Thus, you need only place the right piece of information in the right place. Also, as a rule of thumb, it's always good to include as much information as possible when citing so that it's easier for others to locate the source material.

Notes and bibliography

The following are examples of how to cite in note format. Thereafter, corresponding bibliographic entries are given. Also, please note (②) that your notes must be indented 0.5 (basically one tab) from the left hand side for the first line only.

After providing the complete reference information in the note for the first time, whenever you need to provide the same citation again you can simply do so in a shortened form.

E-book

When consulting e-books, ensure that you always include a URL as well. At times you may also be required to mention the type of e-book format as well, such as .epub, .mobi, .azw, etc. As for page numbers, cite when available. If page numbers are not present then cite the title of that chapter or section.

Journal article

In the bibliography you will enter the whole range of the journal article, while in the note you will specify the specific page, or pages, that are relevant to you.

News Article

Articles from online sources, whether it be blogs or news sites, are cited in like manner. If page numbers are present then they will be included within the notes and shortened notes as well, however will not be included within the bibliography. As always if you take any online source then make sure to include the URL, the name of the website, and the date and year accessed as well.

Website Content

Usually, for notes a full entry of the source material is not needed as you can just mention the website, or webpage, that you are referring to. Also, always make sure to include an access date, especially if the publication date is not present.

Social Media Content

For social media content, notes are usually not needed as simply in-text citation will work just a well. A note is only used in cases of formal citation. Also, if a title is not available, then quote up to the first 160 characters of the post.

Usually, for notes a full entry of the source material is not needed as you can just mention the website, or webpage, that you are referring to. Also, always make sure to include an access date, especially if the publication date is not present. If the publication date is not present then please write "n.d." to indicate so; where "n.d." means "no date."

Social Media Content

For social media content, notes are usually not needed as simply in-text citation will work just a well. A note is only used in cases of formal citation. Also, if a title is not available, then quote up to the first 160 characters of the post.
